CMS Releases Nursing Home COVID-19 Training Data with Urgent Call to Action

Agency thanks nursing homes whose staff have completed free CMS training, but urges remaining homes to take advantage of this resource.

On November 17, CMS publicly recognized the 1,092 nursing homes at which 50% or more of their staff have completed CMS training designed to help staff combat the spread of COVID-19 in nursing homes. CMS applauds these facilities for taking this critical step to equip their staff with the latest information regarding infection control, vaccine distribution, and other topics.

Medicare FFS Estimated Improper Payments Decline by \$15 Billion Since 2016

Continued reduction marks fourth year Medicare FFS improper payment rate has been below 10%.

On November 16, CMS announced that the Medicare Fee-for-Service (FFS) improper payment rate has continued to decline, reinforcing the Trump Administration and CMS' commitment to strengthening Medicare and protecting taxpayer dollars. This translates to less fraud, waste, and abuse that can increase the fiscal burden on the nation's health care system.

CMS Retiring Original Compare Tools on December 1

Use Medicare.gov's Care Compare to find and compare health care providers.

In early September, CMS [released Care Compare](#) on Medicare.gov, which streamlines our 8 original health care compare tools. These original compare tools will retire on December 1, ending this transition period.

[Care Compare's](#) new design makes it easier to find the same information that's on the original compare tools. It gives you, patients, and caregivers one user-friendly place to find cost, quality of care, service volume, and other CMS quality data to help make informed health care decisions. Now, instead of having to search through many compare tools, with just one click on Care Compare, you'll find easy-to-understand information about nursing homes, hospitals, doctors, and other health care providers.

This transition doesn't change how we measure quality. We'll continue to improve Care Compare and the [Provider Data Catalog](#) based on stakeholder and consumer feedback.

Medicare Diabetes Prevention Program: Become a Medicare-Enrolled Supplier

Medicare pays Medicare Diabetes Prevention Program (MDPP) suppliers to provide eligible patients with group-based intervention for up to 2 years, using the CDC-approved National Diabetes Prevention Program curriculum.

Interested in becoming a Medicare-enrolled MDPP supplier?

Follow the [2-step process](#):

1. Get CDC preliminary or full recognition.
2. Then, find out [how to apply](#) to become a Medicare MDPP supplier. Use our [checklist](#) to gather what you need to enroll.

November is Lung Cancer Awareness Month, and November 19 is the Great American Smokeout. Tobacco use is the leading cause of preventable illness and death in the United States. Many smokers want to quit but have difficulty succeeding.

- Talk to your patients about quitting
- Recommend Medicare-covered preventative services, including counseling to prevent tobacco use, lung cancer screening counseling, and annual screening for lung cancer with low dose computed tomography
