

Open Payments System Quick Reference Guide

Data Submission & Attestation Documents and Resources

Introduction

The Open Payments system allows reporting entities (i.e., applicable manufacturers and applicable group purchasing organizations) to submit and attest to payments or other transfers of value made to covered recipients (i.e., physicians/non-physician practitioners (NPP) (including principal investigators), and teaching hospitals). The system also allows for the disclosure of ownership or investment interests information held by physician owners, investors, or their immediate family members. This quick reference guide provides a list of resources available to assist in the data submission process for both bulk file and manual submissions.

Information for Creating Submission Records

Resource Name	Description
<p>Validated Physician List</p>	<p>A non-comprehensive list of U.S. physicians for reference when creating payment records for submission. Includes physicians who have a National Provider Identifier (NPI) number and have been successfully matched by the Open Payments system to at least one payment record from Program Years 2013 through present whether the payment record was published or not. The Validated Physician List (VPL) provides the names, NPIs, and state license information for each physician listed.</p> <p>There is an additional Validated Physician Supplemental List Without NPI that identifies physicians who do not have an NPI and have been reported on in the Open Payments system.</p> <p>Both the VPL and the Validated Physician Supplemental Lists are provided for reference only. If a physician does not appear on either list, it does not mean he/she is not reportable. Physicians that aren't on the VPL may still be successfully matched; users may consult the National Plan and Provider Enumeration System (NPPES) or other data sources for information on reportable physicians not listed on the VPL.</p> <p>The VPL and supplemental files are downloadable CSV files that are only accessible within the Open Payments system on the "Submissions" page.</p>
<p>Non-Physician Practitioner List</p>	<p>A non-comprehensive list of U.S. Non-Physician Practitioners, including Physician Assistants (PA), Nurse Practitioners (NP), Clinical Nurse Specialists (CNS), Certified Registered Nurse Anesthetists (CRNA), Anesthesiologist Assistants (AA) and Certified Nurse-Midwives (CNM). The Non-Physician Practitioner List (NPPL) provides the names, NPIs, and state license information for each Non-Physician Practitioner listed.</p> <p>The NPPL is provided for reference only. If a NPP does not appear on this list, it does not mean he/she is not reportable. Users may consult the NPPES or other data sources for information on reportable NPPs not listed on the NPPL.</p> <p>The NPPL is a downloadable CSV file that is only accessible within the Open Payments system on the "Submissions" page.</p>
<p>Teaching Hospital Lists by Reporting Cycle</p>	<p>Annually updated lists of teaching hospital covered recipients by reporting cycle. Payments made to hospitals on these lists must be reported to CMS for the purposes of Open Payments.</p> <p>The teaching hospital lists per reporting cycle are available on the "Resources" page of the CMS Open Payments website.</p>

List of Drug Names and National Drug Codes (NDC)	<p>A non-comprehensive list of drug names and national drug codes when reporting payments in the Open Payments system.</p> <p>A CSV reference file and a PDF instruction document are zipped together and made accessible within the Open Payments system under the “Resources” tab.</p>
List of Medical Device and Medical Supply Name and Primary Device Identifier	<p>A non-comprehensive reference list of medical device, medical supply name, and primary device identifier information.</p> <p>A CSV reference file and a PDF instruction document are zipped together and made accessible within the Open Payments system under the “Resources” tab.</p>

Error and Warning Code Key	A list of all error and warning codes generated by the Open Payments system during record validation and matching processes.
