With each Quarterly Release, the designated Medicare Administrative Contractor (MAC) converts the English descriptors into Spanish for new or updated HCPCS codes and creates a spreadsheet of the Spanish short descriptors. The Durable Medical Equipment (DME) Shared System Maintainer (SSM) manually updates each Spanish short description based on the information received from the MAC.

This Change Request directs the DME SSM to implement a systematic approach to update Spanish short descriptions for MSNs based on the file created by CMS' designated MAC. By automating this process, CMS will decrease errors.
