The purpose of this Change Request (CR) is to automate setting the date ranges on the QA Selection – Date Card Screen (VMAP/2/2). This screen is used to specify selection criteria for a given QA sample. Claims are randomly selected based on date and dollar amount ranges. VMS writes claims data to a file that will be used for QA transactions.

Currently, the VMAP/2/2 date range needs to be manually set by Durable Medical Equipment Medicare Administrative Contractors (DME MACs) prior to running weekly cycles. Automating the VMAP/2/2 Date set will remove the requirement for DME MACs to set this date weekly and will avoid a cycle delay due to VMAP/2/2 dates not being set by DME MACs.
