# Tips About the FVR

- Hospice Final Validation Report provides feedback about the processing status of each record included in the submission file
- It is vitally important that you print and carefully review each Hospice Final Validation Report



# Tips About the FVR

- Two sections to the FVR
  - Section 1 - Header
    - Contains submission information about the file (Submission Date and Time, Submission ID, Processing Complete Date and Time, etc.)
    - Contains provider information for the HIS records in the submission file (Facility ID [FAC\_ID]), Provider Name, Provider CCN and State Code)
    - Record counts for the submission file (Number of Records Processed, Number of Records Accepted, Number of Records Rejected, etc.)



# Tips About the FVR

- Two sections to the FVR
  - Section 2 – Body
    - Identifies record processing order (the order in which the record was processed by the QIES ASAP system)
    - Identifies record processing status (Accepted or Rejected)
    - Identifies the patient information as submitted in the HIS record (Last and First Name, Birth Date, SSN, Gender and Patient ID)
    - Identifies the HIS record information (Target Date, Type of Record, HIS ID, Reason for Record, XML File Name)
    - Error message information, if present. This includes the HIS item in error, data submitted value that caused the error to occur, error message number and description.



# Types of Error Messages

- Two types of errors could display on the FVR:
  - Fatal
    - If the record contains one or more fatal errors, it is rejected and NOT accepted by the QIES ASAP system
    - The fatal error(s) must be corrected and the record must be resubmitted to the QIES ASAP system
  - Warning
    - If the record contains only warning messages, the record is accepted by the QIES ASAP system
    - Evaluate the message to determine if the error must be addressed

\*If a record contains both Fatal and Warning errors, Fatal errors take precedence; the record is rejected
