

# Clinician Performance Information on Medicare Care Compare Performance Year 2018

## Overview

This document summarizes the clinician performance information, measure and activity titles<sup>1</sup>, and utilization data that are publicly reported on [Medicare Care Compare](#) and in the [Provider Data Catalog \(PDC\)](#).<sup>2</sup> Care Compare and the PDC are publicly reporting doctor and clinician performance information from the 2018 Quality Payment Program. Performance information that meets statistical public reporting standards (valid, reliable, comparable, and meet the minimum reliability threshold) will be included in the PDC.<sup>3</sup> A subset of this information will be added to Care Compare profile pages for doctors and clinicians. Any information publicly reported on profile pages must also resonate with patients and caregivers, as shown through user testing. Per the Medicare and CHIP Reauthorization Act (MACRA), eligible clinicians' final and performance category scores must be publicly reported and aggregate data must be publicly reported periodically. Additionally, Care Compare will publicly report a subset of 2017 clinician utilization data in the PDC.
