**POST-EVENT TRAINING MATERIALS AVAILABLE:** IRF and LTCH Updated Guidance Virtual Training Program

The Centers for Medicare & Medicaid Services (CMS) is offering a virtual training program that provides instruction on the updated guidance for the Inpatient Rehabilitation Facility Patient Assessment Instrument (IRF-PAI) 4.0 and the Long-Term Care Hospital (LTCH) Continuity Assessment

Record and Evaluation (CARE) Data Set (LCDS) 5.0 for providers in the IRF and LTCH settings.

The IRF and LTCH Virtual Training Program consists of two parts:

1. **Part 1 – Training Webinars:** pre-recorded training videos that provide an overview of the new items and updated guidance that are *intended to be viewed prior* to the Workshop sessions.
2. **Part 2 – Workshop Sessions:** recorded videos of the live, virtual workshop sessions that took place on June 15<sup>th</sup> and 16<sup>th</sup> and provide coding practice of the information covered in the Training Webinars.
