Background

CR 13818 is a maintenance update of ICD-10 conversions and other coding updates specific to NCDs. These NCD coding changes are the result of newly available codes, coding revisions to NCDs released separately, or coding feedback received.

Translations from ICD-9 to ICD-10 aren't consistent 1-to-1 matches, nor are all ICD-10 codes appearing in a complete General Equivalence Mappings mapping guide or other mapping guides appropriate when reviewed against individual NCD policies. Also, for policies that allow MAC discretion, NCDs may change based on current review of those NCDs against ICD-10 coding. For these reasons, some ICD-9 codes that were appropriate before ICD-10 implementation are no longer valid.
