A. Background: The purpose of this CR is to direct the Medicare shared system maintainers to obtain the most recent external code sets, and use them to update the necessary tables and/or reference files as part of the CCEM software utilized by the A/B MACs.

In order for the Medicare fee-for-service program to correctly and accurately edit the inbound Accredited Standards Committee X12 version 5010 837 Institutional, 837 Professional claims, and the 276 Claim Status Inquiry, several code set updates are required. These are common code sets that are used across both the Part A and Part B CCEMs and are updated on a regular basis.

B. Policy: Health Insurance Reform: Modifications to the Health Insurance Portability and Accountability Act: Final Rules published in the Federal Register on January 16, 2009, by the Department of Health and Human Services at 45 Code for Federal Regulation Part 162.
