#### House Language for NIEHS on FY24 Appropriations

House FY24 Labor-HHS  Urges NIEHS to continue Harmful Algal Blooms Research and invest in the Oceans and Human Health program

House FY24 Interior, Environment and related Agencies  NIEHS is encouraged to continue its work supporting communities' capacity to respond to pandemics and disasters.

#### Senate Language for NIEHS on FY24 Appropriations to date

#### Senate FY24 Labor-HHS

- Climate Change and Health research
- Environmental Exposures and Cancer in Fire Fighters
- East Palestine Train Derailment Research and Community Engagement activities
- Indoor Air research

Senate FY24
Interior,
Environment and related Agencies

- \$2 million in base funds for research for PFAS and other contaminants of emerging concern
- Not less than \$1,750,000 to support risk reduction for Native Americans to hazardous metals mixtures from abandoned uranium mine waste
- Commends the work of NIEHS Worker Training Program and asks the Institute to continue to prioritize resources and support for the program

### Minibus Bills Report Language for NIEHS on FY24 Appropriations

FY24 Labor-HHS

- None
- Senate language to be treated same as in Minibus explanatory statement

FY24 Interior, Environment and related Agencies

- \$2 million in base funds for research for PFAS and other contaminants of emerging concern
- Not less than \$1,750,000 to support risk reduction for Native Americans to hazardous metals mixtures from abandoned uranium mine waste

#### **Final FY24 Appropriations**

- The week of March 4<sup>th</sup>, the House and Senate passed, and the President signed into law 6 of the 12 Appropriations bills (H.R. 4366 or the Minibus)
  - For NIEHS, the Interior and Environment bill was included in the Minibus, and our Superfund-related programs (SRP and WTP) are funded at \$79,714,000, which is a cut of \$3,321,000 or about 4% below FY23 levels.
- The week of March 18<sup>th</sup>, the House and Senate passed, and the President signed into law the remaining 6 appropriations bills through the final minibus (H.R.2882)
  - For NIEHS, the Labor-HHS provision remained flat at FY23 levels for FY2024 at \$913,979,000.

#### Past Language for DOE provision:

 Past language has been under DOE Defense Environmental Cleanup provision in Energy-Water Subcommittee bill:

-"Within available funds, \$10,000,000 is provided to fund the hazardous worker training program."

### Original Authority in the FY1992 and FY1993 NDAA (P.L. 102-190):

- Sec. 3124
- "Funds appropriated pursuant to this title may be transferred to other agencies of the Government for the performance of the work for which the funds were appropriated, and funds so transferred may be merged with the appropriations of the agency to which the funds are transferred."

- Sec. 3131
- "(2)(B) The Secretary shall give preference in the award of grants under this section to employee organizations and joint labor-management training programs that are grant recipients under section 126(g) of the Superfund Amendments and Reauthorization Act of 1986 (42 USC 9660a)."

#### **FY2025 President's Budget**

- President Biden released his FY25 Budget on March 11, 2024.
- For the **Labor-HHS** portion of the NIEHS budget, the President's FY25 Budget proposes \$916,791,000.
  - **\$2,984,000** increase (or **0.3**%) over FY23 and FY24 enacted levels
- For the Interior and Environment (NIEHS Superfund related programs) portion of the NIEHS budget, the President's FY25 Budget proposes \$83,035,000,
  - \$3,321,000 or about a 4% increase over FY2024 levels signed into law on March 9, 2024.
  - This FY25 budget proposal is flat from FY23 enacted levels.
