## DailyMed Web Site Now Available

March 07, 2006 [posted]

The Food and Drug Administration (FDA) and the National Library of Medicine® (NLM) have signed a memorandum of agreement calling for NLM to receive from the FDA the electronic product labels (often referred to as package inserts) of medications, after the FDA has approved the label. NLM then publishes the labels electronically, and provides them for download.

The DailyMed Web site: [dailymed.nlm.nih.gov](http://dailymed.nlm.nih.gov) provides a primary vehicle for access to the labels as well as to other sources and types of information about medications. Links are available for drug topic searches in PubMed®, MedlinePlus®, and ClinicalTrials.gov, as well as a link for reporting an adverse event to the FDA. Information from the Veterans Administration on pharmacologic actions and uses of medications will also be available.

The product labels are prepared in a standardized format that was developed in consultation with the industry and with HL7, a standards development organization. The rule requiring manufacturers to submit their labels electronically in this format went into effect in October 2005. On November 1, the first label was transmitted to NLM for publication. The practice of the FDA is to review and approve each label every year. Thus, over the next 12 months, the Library expects to receive the approved label for every medication on the market.

## **PubMed® Maintenance for EDATs on Older Citations**

**March 08, 2006** [posted]

On PubMed® records, the Entrez date (EDAT) is the date the citation was added to the database. An exception to this is when we add citations that have a publication date **prior** to September of 1997. For these records the Entrez Date is set to the Publication Date. This is done because PubMed's default display of search retrieval is in reverse Entrez date order (last in, first out) and we recognize users' preference to see currently published citations at the top of their retrieval.

There are approximately 300,000 older citations in PubMed that do not follow this exception. We will change the EDAT on these citations to reflect the publication date. The MeSH Date (MHDA) will remain unchanged.

## **MedlinePlus® Adds Tutorial on Evaluating Internet Health Information**

As consumer health information explodes on the Internet, teaching people how to evaluate information for accuracy and authority becomes more and more important. With this in mind, MedlinePlus now features a tutorial on the topic.

Evaluating Internet Health Information is a 16-minute narrated slideshow. The tutorial runs automatically, but you can use the navigation bar at the bottom of the screen to go forward, backward, pause, or start over. Using fictional "good" and "bad" Web sites, the tutorial walks the user through a comparison of the two, pointing out features to look for concerning the information provider, funding source, quality, and privacy. The tutorial uses plain language and narration and is appropriate for users at a broad range of reading levels.

## **UMLS® 2006AA Release, February 2006**

## **Metathesaurus**

The 2006AA Metathesaurus contains more than 1.2 million concepts and 6 million unique concept names from 118 source vocabularies. In the 2006AA release, 22 source vocabularies were updated including HCPCS, Altlink, CPT, and UMDNS.

## **Rich Release Format (RRF) Browser**

The RRF Browser has been integrated into MetamorphoSys. This tool allows users to view and search their customized Metathesaurus subsets. Recent enhancements include expanded search capacity, a tree view for concepts, and linked concept reports. Documentation is available at

## **TOXMAP Adds New Chemical and Health Data**

In response to feedback from users, the National Library of Medicine (NLM) has added new chemical and health-related data to its interactive mapping site, TOXMAP.

Released in September, 2004, TOXMAP helps users explore the geographic distribution of certain chemical releases, their relative amounts, and their trends over time. This release data comes from industrial facilities around the United States, as reported annually to the Environmental Protection Agency (EPA).

Now, users can also use TOXMAP to find information about Environmental Protection Agency (EPA) Superfund sites and substances. The Superfund program is part of a federal government effort to clean up land in the United States that has been contaminated by hazardous waste and identified by the EPA as a candidate for cleanup because it poses a risk to human health and/or to the environment.

The substances found at Superfund sites have been designated as causing or contributing to an increase in mortality or in irreversible or incapacitating illness, or posing a substantial present or potential hazard to human health or to the environment when improperly treated, stored, transported, disposed of, or otherwise managed. More than 800 substances are currently designated as hazardous, and many more as potentially hazardous.

TOXMAP has also added mortality data from the Centers for Disease Control and Prevention (CDC) and the National Cancer Institute (NCI), as well as age and gender data from the US Census, and income data from the Bureau of Economic Analysis.

TOXMAP links to NLM's extensive collection of toxicology and environmental health references, as well as to a rich resource of data on hazardous chemical substances in its TOXNET databases. The resource also provides fact sheets and summaries about the various chemicals, written by the Agency for Toxic Substances and Disease Registry, and EPA progress reports on the Superfund sites.

Since many users may not be experienced in reading maps or understanding map data, TOXMAP provides a Frequently Asked Questions (FAQ) and a Glossary of Terms. Both resources attempt to provide questions/answers to supplement the user's ability to understand the map displays and the data.

Without both factors there is no risk. If we take care to limit our exposure and handle these substances safely, we reduce our risk. My NCBI Saved Searches and RSS feeds that were created using a date selected from the old PubMed® Limits screen should be recreated as these old limits are no longer working. Recreate your searches using date limits from the new Limits screen (and delete the old searches). Searchers are reminded that updates are, by definition, citations for recent publications that are new to PubMed and will not include citations for articles published before September 1997. Therefore, date limits

are not recommended for strategies used to create My NCBI updates or RSS feeds.

The 2004 Toxics Release Inventory (TRI) has been released on TOXNET. The new release (1987-2004) contains 1,553,330 records.

The U.S. Environmental Protection Agency's (EPA) TRI provides information on the releases of over 600 specific chemicals into the environment as reported annually by industrial facilities around the United States.

NLM's TOXMAP uses maps of the United States to help users visually explore TRI and Superfund Program data.

NLM's TOXNET is a group of databases on hazardous chemicals, environmental health, and toxic releases.

## **LactMed: A New Database on Drugs and Lactation from NLM®**

LactMed, a free online database with information on drugs and lactation, is one of the newest additions to the National Library of Medicine's (NLM) TOXNET® system, a Web-based collection of resources covering toxicology, chemical safety, and environmental health.

Geared to the healthcare practitioner and nursing mother, LactMed contains over 450 drug records. It includes information such as maternal drug levels in breast milk, infant levels in blood, potential effects in breastfeeding infants and on lactation itself, the American Academy of Pediatrics category indicating the level of compatibility of the drug with breastfeeding, and alternate drugs to consider. References are included, as is nomenclature information, such as the drug's Chemical Abstract Service's (CAS) Registry number and its broad drug class.

LactMed was developed by a pharmacist who is an expert in this subject area. Three other recognized authorities serve as the database's scientific review panel. Ancillary resources, such as a glossary of terms related to drugs and lactation, and breastfeeding links are also offered. LactMed can be searched together with TOXNET's other databases in a multi-database environment, to obtain other relevant information about drugs. As a work in progress, LactMed will continue to expand with additional drugs and be enhanced with other substances, such as industrial chemicals

and radiation.

## PubMed® Limits Page Updated

**T**he PubMed Limits page will soon be redesigned to provide an improved interface to limit your search by age group, gender, human or animal studies, languages, publication types, dates and other parameters. Click the Limits tab to display the Limits page.




Figure 1: The new Limits page (partially shown).

Enhancements include new limits such as "Links to free full text," the ability to choose one or more selections under categories such as Languages, and a search builder for authors and journals (see Figure 1).

### Searching by Author or Journal





Figure 2: Add Author on the Limits page.

To search by author, click **Add Author**. An author search box will display. The author search box includes an autocomplete feature; enter a name in the Author name box and you will see a list of suggested names that gets shorter as you type more letters. As soon as you see the author name you are looking for, you may select that name (see Figure 2).

To add additional authors, click the **Add Another Author** link to open another author search box. The default author



Author names will automatically move to the PubMed search box when you click Go. Selected limits will be activated for any subsequent searches except for authors and journals. Author and journal selections will only be included in subsequent searches if they are not cleared from the PubMed search box (see Figure 4).

When Limits are "in effect," a check will appear in the Limits tab and your selected limits will display in a yellow bar. To turn off limits click off the Limits tab check box and run a new search.

To limit your search to a journal, click **Add Journal**. A journal search box will display. The journal search box also includes an autocomplete feature; enter a name in the journal name box and you will see a list of suggested names that gets shorter as you type more letters. As soon as you see the journal title you are looking for, you may select it. To add additional journals, click the **Add Another Journal** link to open another journal search box. Search results will include any of the selected journals. Journals will automatically move to the PubMed search box when you click Go. Author and journal selections will only be included in subsequent searches if they are not cleared from the PubMed search box (see Figure 4).

### **Full Text, Free Full Text, and Abstracts**




**Figure 5: Full Text, Free Full Text, and Abstracts Limits boxes.**

To limit your search results to only citations that include a link to full text, a link to free full text, or an abstract, click the appropriate checkboxes (see Figure 5).

## Dates

You may limit your search to articles published or added to PubMed by a pre-set date range (see Figure 6) or you may enter any desired date range (see Figure 7).

## Additional Limits Categories

Limits categories for Humans or Animals, Gender, Languages, Subsets, Type of Article (Publication Types) and Ages have been modified to allow users to choose multiple selections within each category. The complete lists of languages and publication types are also now available under the labels: More Languages and More Publication Types.

Scroll through the Subsets category to display topics such as Systematic Reviews, journal groups such as nursing journals, and more subsets such as PubMed Central (see Figure 8).

**Go** and **Clear All Limits** buttons are available at the bottom of the Limits page. The Go button function at the top and bottom of the page is equivalent.



## New Search and Display Options Available in the Journals Database

*[Editor's Note: This feature was implemented in PubMed on March 29, 2006.]*

The Entrez Journals Database will soon include new options for searching, an additional display format, and an expanded Full format. The new search options are **Subject Terms** and **Currently Indexed in MEDLINE®**.




Figure 1: Full display format in the Journals database.

These new options will be searchable from the Limits screen, Preview/Index, or directly in the query box. An XML format will be available as a display option. The Full display format has been given a new look and also expanded to include the Subject Terms and additional information available about the journal displayed in "Continuation Notes" (see Figure 1).


### Currently Indexed

Currently Indexed means MeSH® terms will be assigned to citations for articles within scope for MEDLINE. Use the

check box on the Journals Database Limits page to limit a search to journals that are currently indexed for MEDLINE(see Figure 2). These records may also be searched by adding the string **AND currentlyindexed** to a search query. For example:

nursing AND currentlyindexed

While this can be searched, this information is not displayed on Journals Database records.

### **Subject Term [st]**

Subject Terms are assigned by NLM® at the journal level to describe the journal's overall scope. The search tag for this new field is [st]. The Subject Terms will display in the Full and the XML (as <BroadJournalHeading>) display formats. The complete list of terms is available at the Journal Subject Terms Web page. For example, searching for the non-tagged term pediatrics in the Journals database, will now retrieve all journals that include the word pediatrics in the title as well as journals with the Subject Term, Pediatrics.

## GEO Accession Numbers in MEDLINE®

**A**ccession numbers for a new database, the Gene Expression Omnibus (GEO), are now being added to MEDLINE records when a journal article reports that new data has been added to this database. GEO is a "gene expression/molecular abundance repository supporting Minimum Information About Microarray Experiment (MIAME) compliant data submissions, and a curated, online resource for gene expression data browsing, query and retrieval." Additional information is available at: <http://www.ncbi.nlm.nih.gov/geo/>. GEO was developed and is maintained by the National Center for Biotechnology (NCBI). It consists of three different types of entries: Platform, Sample, and Series. The Platform record contains lists of elements on an array (such as a oligonucleotide microarray) or a list of elements that may be detected or quantified in the experiment. The Sample record is a description of the handling of a Sample. The Series record defines a set of related Samples.

GEO accession numbers have a standard format which consists of one of four prefixes followed by one or more numbers. The four prefixes are:

- GDS (for GEO Data Set)
- GSE (for GEO SERIES)
- GPL (for GEO PLatform)
- GSM (for GEO SaMple)

GEO accession numbers will display in the Secondary Source Identifier (SI) field in PubMed's Citation and MEDLINE display formats (and in the <DataBankList> area of the XML format). Here's an example from the Citation display:

Secondary Source ID:

- GEO/GSE3847

GEO numbers may be searched in PubMed using the [si] search tag in the following ways:

1. To retrieve a specific accession number:

`geo/gse3847 [si]`

or, more simply, as:

`gse3847 [si]`

2. To retrieve all GEO accession numbers:

`geo [si]`

3. Click on the search link in the Citation Display.

## NLM Classification 2006 Edition Now Available

The *NLM Classification*, available online at <http://wwwcf.nlm.nih.gov/class/>, incorporates all additions and changes to the schedules and index from April 2005 through March 2006. This edition includes an online tutorial on searching the *NLM Classification*.

### Major Changes

Proteins and bacteria were the major areas revised for the 2006 edition.

- The general class number for proteins, QU 55, was subdivided in order to parallel the arrangement of the MeSH thesaurus and better fit trends in the literature. NLM believes these new numbers for categories of proteins provide a more coherent shelf arrangement of works in this broad topic area and better control the volume of material formerly assigned to this single class number.
- Several class numbers in the bacteria section of the QW schedule were added, modified, or canceled to better reflect the current taxonomy in *Bergey's Manual of Systematic Bacteriology*, 2nd ed. However, because a major overhaul of this section of the schedule would have been impractical, the extent of the revision for bacteria was necessarily limited.
- New class numbers were added and existing class numbers were canceled as needed to reflect other changes in MeSH and the biomedical and related sciences literature cataloged.

### Other Changes to the Schedule

- Selected class number captions were augmented to clarify their scope, e.g., at QW 50, the caption was changed to *Bacteria (General). Bacteriology. Archaea.*
- Selected schedule captions were revised to reflect changes in MeSH, e.g., at QV 55, Drugs was changed to *Pharmaceutical preparations.*
- Various instructional notes were added or modified to clarify classification practices, e.g., at the beginning of the WY schedule, an example was added to the second note to clarify classification of works on nursing care of a specific disease.

## Changes to the Index

- Ninety-eight (98) new main index entries were created, fifty-seven (57) of which are from the 2006 MeSH; the remainder are MeSH terms from previous years.
- Numerous main index entries and cross references were modified to reflect changes in the MeSH vocabulary. In particular, major categories of index terms affected by MeSH changes include:

Terms changed to clarify meaning for use in non-medical databases, e.g.:

*Fractures to Fractures, Bone*  
*Labor Complications to Obstetric Labor Complications*

Terms replaced by more current or scientific terms, e.g.:

Hay Fever to Rhinitis, Allergic, Seasonal  
Clams to Bivalvia

- Various instructional notes were added to index entries to clarify classification practices. For example, to more fully account for their medically relevant facets, improved classification guidance has been added to the index for certain headings in the areas of nursing, history (wars and events), pharmacology, and the digestive system (liver and biliary tract).
- All index entries pertaining to the aforementioned schedule additions and changes were modified.


## Skill Kit: Customize the Display of Your NLM Gateway Search Results

**T**he NLM Gateway provides the ability to customize the display of your search results. You can easily change the data included in both the Brief format and the Expanded format to suit your needs. Registered Gateway users can even create their own standard default display. Follow the instructions below, or see and hear the Quick Tour.

Perform a search in the Gateway and select a collection from the Results Summary. The Results Page displays the items from that collection in a Brief format (e.g., title, author, source information). To see additional, specific data, click on the title and go to an Expanded view of the item. You can eliminate this last step by customizing the Brief format to display the specific fields you want.

Let's say that you are interested in health services research in the area of diabetes, specifically the funding information related to the research and where the research is being performed. You can customize the display of the Brief format of Health Services Research Projects (HSRProj) records to include that data.

1. Click on Limits/Settings on the Gateway Features bar.
2. Click on the Select Fields tab. Go to the pull-down (Choose a collection) menu on Select Fields and select HSRProj. Click on Go. See Figure 1.

3. In the list of fields, select "Grant Support," clicking in the box in the Brief Format column (see Figure 2). Scroll down and do the same for "Performing Organization" and "Supporting Agency."





5. Click on Search or use the Enter key. The Results Summary page will display.
6. Click on HSRProj. Notice that the Brief display now includes the names of the Performing Organization and Supporting Agency and the Grant Support information (i.e., grant number)(seeFigure 4).

You can customize the Brief and the Expanded displays for any of the collections. You can also customize a display and save it for future sessions, if you are signed in. For example, to always see the Abstract in PubMed® brief displays repeat steps 1 & 2, selecting PubMed. In the Brief Format column, click on Abstract. Click on "Save" at either the top or the bottom of the field table.

If you aren't currently signed in, a Sign in page will be displayed. Enter your User ID and Password and click on Sign In. (If you have not previously established a User ID and Password for the Gateway, click on "Create one now" at the top of the Sign in page and follow the instructions on the screen. This registration is free and very little information is required.)

The system will display the message: **User preferences saved** (see Figure 5). The preferences are permanently saved until you change them and used whenever you are signed into the Gateway.

After changing the Brief format display for PubMed to include the abstract, search *diabetes* and note that Gateway now shows the abstract in the Brief display of the PubMed results (see Figure 6).

Obesity has been described as an epidemic because of the rapid increase in the number of overweight and obese individuals over the past 20 yr. This increasing prevalence of obesity is a worldwide phenomenon affecting both children and adults. The metabolic syndrome is a constellation of central adiposity, impaired fasting glucose, elevated blood pressure, and dyslipidemia (high triglyceride and low HDL cholesterol). When three of these five criteria are present, the risk of cardiovascular disease and diabetes is increased 1.5- to 2-fold. As body weight, expressed as the BMI, rises, there are a number of other diseases that are associated with it. First, life span is shortened and the risk of sudden death increases. Second, the risk of diabetes, gall bladder disease, hypertension, heart disease, osteoarthritis, sleep apnea, and certain forms of cancer also increase.

## DOCLINE® 2.7: The Next Generation of Routing

**O**n March 29, 2006, the U.S. National Library of Medicine® released DOCLINE 2.7. DOCLINE is an automated interlibrary loan request and routing system. DOCLINE provides health science libraries in the National Network of Libraries of Medicine (NN/LM), Canada, Mexico, and select international libraries with means to request biomedical literature.

The new version of DOCLINE contains key enhancements requested by DOCLINE users. DOCLINE 2.7 introduces routing by library group, requesting by service level (rush and urgent patient care), limiting routing to Electronic Fund Transfer System (EFTS) participants, routing by multiple delivery methods, searching serial holdings by delivery method, and a new appearance and functionality for serial holdings searching.

### Borrowing

DOCLINE 2.7 adds several major enhancements to the request (borrowing) functionality. The most significant change is the ability to route requests by a Library Group as well as to individual libraries.

Prior to DOCLINE 2.7, borrowers were limited to listing 180 libraries as potential lenders for their requests, grouped in a hierarchy of nine Routing Table cells. Routing by Library Group widens the available pool of libraries to which a request may route by allowing a Library Group to be added to a Routing Table cell. Membership in the various Library Groups ranges from eleven libraries to more than 1,000 libraries. During routing, DOCLINE will randomly select up to a maximum of 20 libraries per Routing Table cell to which requests will route - libraries that report owning the title volume or year and that also match the other routing instructions. With DOCLINE's intelligent routing, a request typically does not need to route to more libraries to be filled, but a request may need more libraries to which it has the possibility to route.

DOCLINE 2.7 also adds libraries in the NN/LM level of "Other" to the end of the routing algorithm. "Other" libraries consist primarily of special libraries, associations, and Canadian libraries. The Routing by Library Group feature and the addition of "Other" libraries to the routing make it possible for borrowers to include every DOCLINE library as a potential lender for a request, thereby utilizing the full resources of the NN/LM and DOCLINE. When placing a request, the borrower's default ordering preferences are displayed. A borrower can modify the default values on a request-by-request basis depending upon the needs of the patron. DOCLINE 2.7 added service levels to the request module (see Figure 1, item 1). The service levels of Normal, Rush, and Urgent Patient Care indicate the urgency of the borrower and carry with it different rules in DOCLINE. For example, a request can be placed with the level "Urgent Patient Care," indicating that it is needed for immediate clinical care of a patient. These requests should be processed immediately by the lender, and with electronic delivery, could be received by the borrower within hours.

With DOCLINE 2.7, borrowers now have the option of limiting the routing of their requests to participants of the EFTS (see Figure 1, item 2). EFTS is a transaction-based electronic billing system developed by the University of Connecticut Health Center for ILL and document delivery charges. This option allows borrowers and lenders to reduce cost and paperwork associated with paper invoices.

DOCLINE 2.7 also adds the ability to specify multiple delivery methods (see Figure 1, item 3). This enhancement takes advantage of the growing use of electronic delivery. The ability to specify one or more acceptable alternate delivery methods adds greater flexibility and control over routing for borrowers. Libraries continue to indicate a single preferred delivery method for Network libraries, as well as a distinct NLM delivery method.


During routing of a request, cell by cell, DOCLINE will route first to libraries that hold the year or volume of the title requested and that support a borrower's preferred delivery method, and then route to libraries that support one of the borrower's alternate delivery method(s). For example, if a borrower's preferred network delivery method is Web PDF and the alternate delivery methods are Email PDF and Ariel, the algorithm would first route to libraries in cell 1 that deliver via Web PDF, and then try to route to libraries in cell 1 that support Email PDF OR deliver via Ariel. If the request had to route on to cell 2, it would first route to libraries in cell 2 that deliver via Web PDF, and then try to route to libraries in cell 2 that deliver via Email PDF OR deliver via Ariel, and so on.

New features for the request "receipt" include the addition of service level (see Figure 2, item 1) in the request header. The primary "Ship to" address continues to display at the top of the page (see Figure 2, item 2) while DOCLINE 2.7 added the alternate delivery methods in the body of the receipt (see Figure 2, item 3). When the borrower restricts routing to EFTS participants, the request receipt alerts lenders to the billing method in the "Bill to" area (see Figure 2, item 4).

DOCLINE displays a summary of a library's current request activity on the homepage (see Figure 3). It also lists requests to the library as a lender awaiting receipt or awaiting action, and warns the library of requests which will be automatically rerouted on to another library unless acted upon that day. Rush and Urgent Patient Care requests as well as color copy requests are indicated separately on the homepage as "Special Handling" requests to identify to libraries those items needing expedited or special handling.

## Serial Holdings

DOCLINE 2.7 provides a new appearance and enhanced functionality to the search interface to the serial holdings records in DOCLINE. The search interface is available to libraries primarily for the updating of their holdings data. However, libraries can also search the holdings of other member libraries by serial title. For the efficient routing of requests, libraries must maintain accurate serial holdings and institution records so that the routing algorithm has current holdings data and ILL service information to act upon.

The Serial Holdings Add/Update and View search screens have been combined into one search interface - Update/View (see Figure 4). User permissions to view or update Serial Holdings remain unchanged. Users with view only permissions will now search Serial Holdings via the same interface as those who have edit permissions. User permissions for DOCLINE are maintained by the Regional Medical Libraries and the Canada Institute for Scientific and Technical Information (CISTI).

The Bibliographic Search has been revised to provide a more appealing interface with quick access to commonly used search features. Search filters have changed so that the most popular filters are easily accessible on the initial Serial Holdings Update/View screen. Year(s) Owned, Volume(s) Owned, and LIBIDs filters are displayed first, followed by the Top Filters of My Library, My Library Groups, My Region, My Routing Table, Not My Routing Table, and My State/Province.

Libraries can further limit their search results by clicking on the Additional Filters link. Additional filters include Delivery Methods, Membership information, Interlibrary Loan services, State/Province, Region, and Library Groups (see Figure 5).

## ISRCTN to be Added to MEDLINE®/PubMed® Data

Starting in May 2006, the National Library of Medicine® (NLM) will be including the International Standard Randomised Controlled Trial Number (ISRCTN) in MEDLINE/PubMed records, when that information appears in the original publication. For information about the ISRCTN, please see the ISRCTN Register. For more background information please see the International Committee of Medical Journal Editors (ICMJE) Web site for their editorial and updates on the topic of registering clinical trials before publication of the results.

The ISRCTN data will appear in PubMed in the Secondary Source ID list in the Citation display, in the SI field of the MEDLINE tagged display, and in the DataBankList elements of the XML display. The general display format for the data is: an alphabetic label of ISRCTN followed by a slash and then a 14-digit alphanumeric string starting with ISRCTN followed by eight numbers. An example in the Citation format display would be:

Secondary Source ID:

- ISRCTN/ISRCTN46889466

If there are multiple ISRCTN numbers mentioned in one journal article, all will be added to the MEDLINE/PubMed record.

In PubMed, the data will be searchable using the [si] search tag; each of the pieces or the entire string is searchable, e.g.:

```

Use "isrctn [si]" to retrieve all citations to articles listing trial registration in the ISRCTN Register regardless of which particular trial is involved.

In addition, on the Citation display, ISRCTN numbers will link directly to the trial information on the ISRCTN Register Web site.

NLM also includes the ClinicalTrials.gov identifier number in its journal citations.

*[Editor's Note: NLM has edited citations created before May 2006 if an ISRCTN number appeared in the citation's article title or abstract to create a Secondary Source ID (SI) occurrence. The earliest known citation has a publication date of 2001.]*

This goal becomes even more important as the population becomes more culturally diverse. For the library profession, this means transforming our services and collections to meet the health information needs of individuals from a variety of ethnic and racial backgrounds. In order to provide culturally and linguistically appropriate health information, collections and services should reflect the ever-changing face of today's communities. Additionally, librarians should strive to become more aware of the cultural differences that impact the information seeking behavior of the increasingly diverse communities that they serve. This will require librarians to employ strategies that transcend barriers of culture, ethnicity, religion, and language. Cultural competency is defined as a set of values, behaviors, attitudes, and practices that enable people to work effectively across racial/ethnic and cultural lines. This four-hour symposium focuses on the importance of delivering culturally competent library services, resources, and collections.
