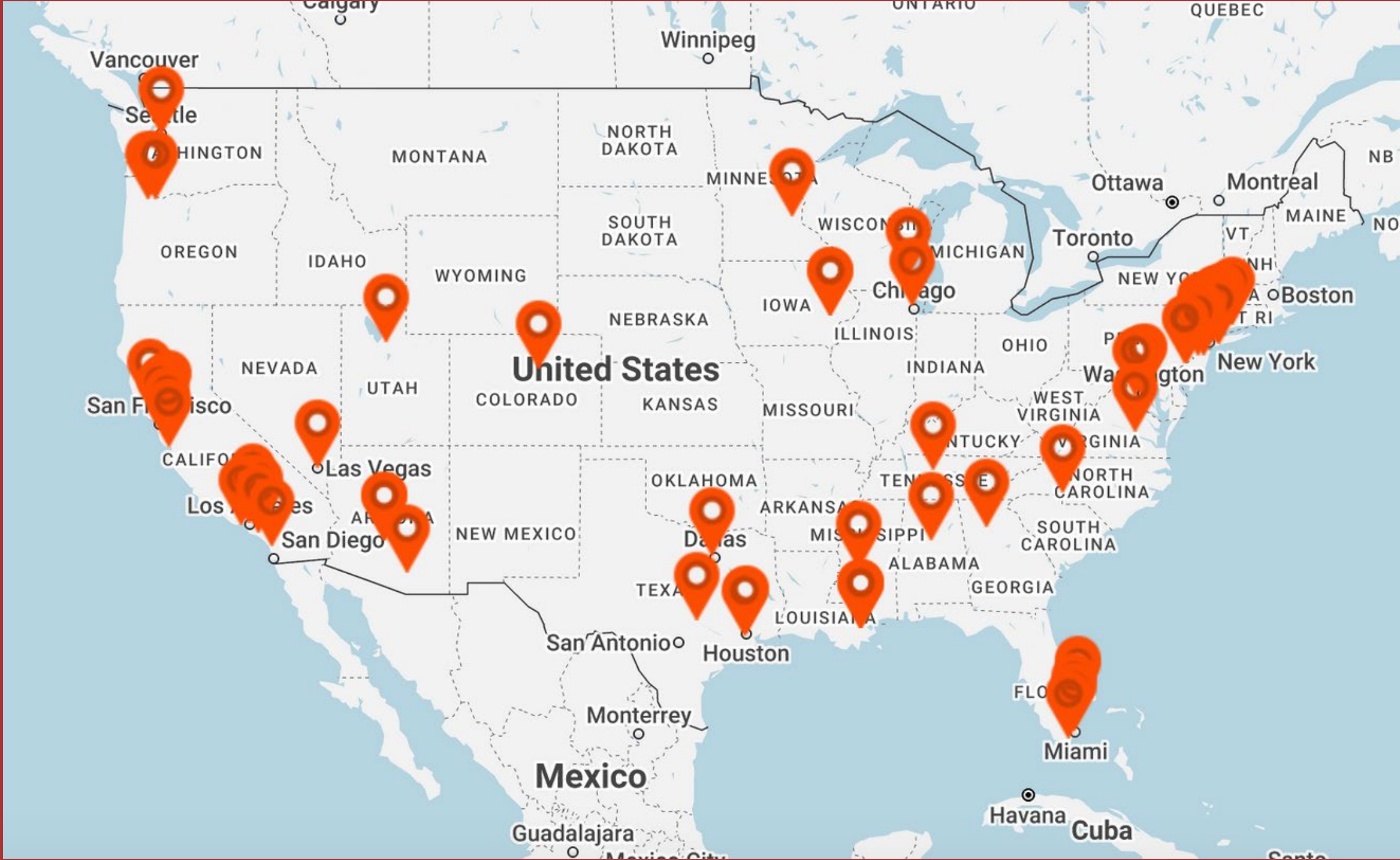

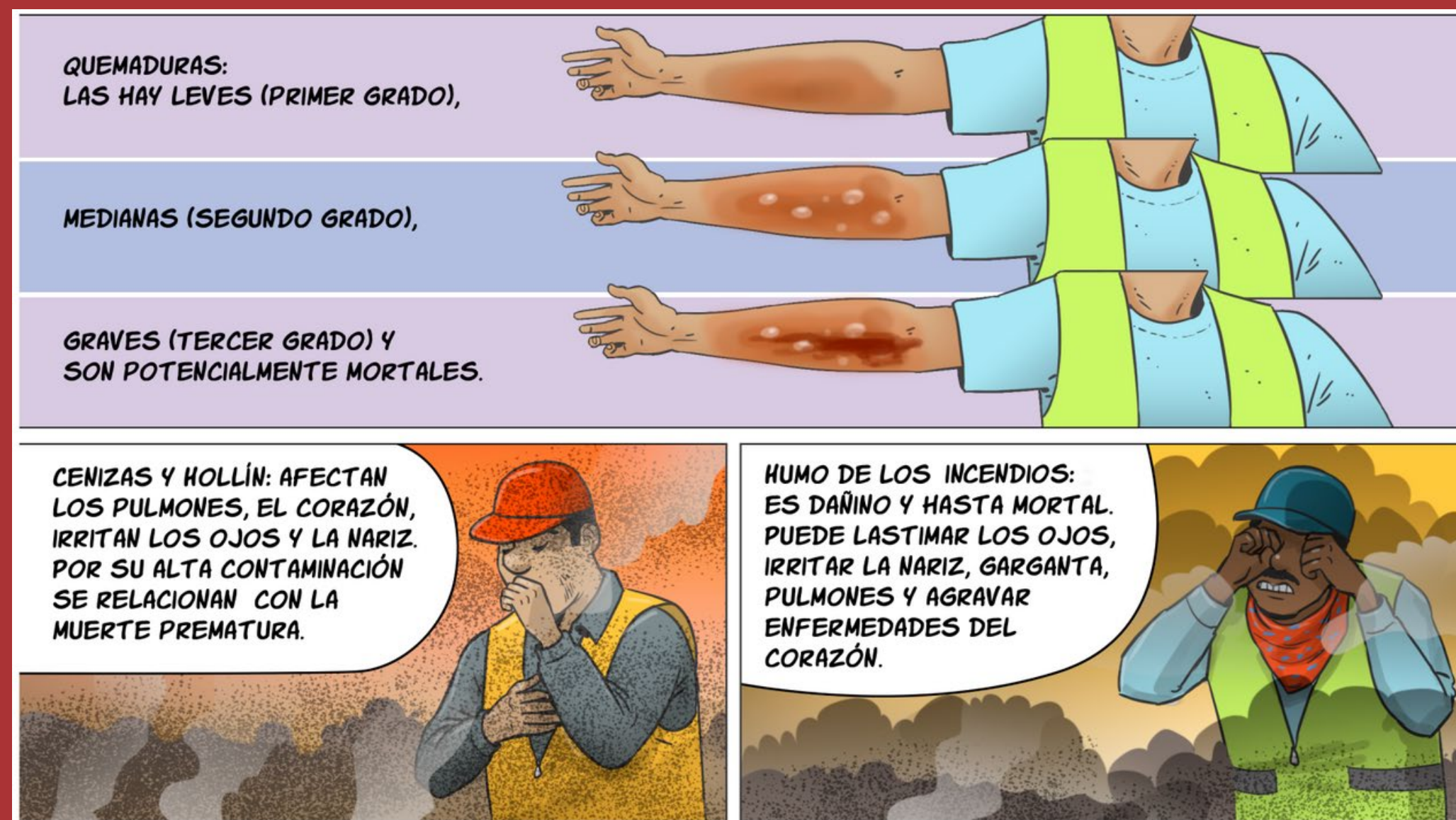

DHS ANNOUNCEMENT



On January 13, 2023, DHS announced its support for labor law enforcement.

Now, any agency investigating labor abuses can write a statement of government interest that explains the potential for retaliation at a workplace or company under investigation for labor violations.

This statement creates eligibility for covered workers to petition DHS for temporary protection and work authorization.
