Interesting Facts from SSA's National Beneficiary Survey (NBS)

## How many hours do beneficiaries work and what are their wages? How does work activity vary by title?\*

- Fewer SSI-only recipients were working at the time of the interview in 2010 than SSDI-only or concurrent beneficiaries (5% compared to 8% and 9% respectively).
- Employed SSI-only recipients worked more hours at their current job than employed SSDI-only or concurrent beneficiaries (an average of 26 hours per week, compared to 19 and 20 hours per week respectively).
- Employed SSDI-only beneficiaries earned higher hourly wages at their current main job than employed SSI-only and concurrent beneficiaries (an average of \$8.86 per hour, compared to \$7.74 and \$6.42 per hour respectively). The federal minimum wage was \$7.25 per hour in 2010.
- Employed SSI-only recipients made more per month at their current main job and were more likely to be earning above substantial gainful activity (SGA) than employed SSDI-only and concurrent beneficiaries, but this was driven by their higher number of hours worked rather than higher wages.
- Almost half (49%) of employed concurrent beneficiaries were working in sheltered workshops, compared to 36% of SSIonly beneficiaries and 37% of SSDI-only beneficiaries. This helps explain why the average hourly wage for concurrent beneficiaries is below minimum wage.
